

IMPORTANT PUBLIC MEETING WITH ODOT SCHEDULED FOR JANUARY 22

ODOT will be holding a public information meeting with the members of the Mariemont Community Planning Council (CPC) on January 22nd, at the Mariemont Elementary School Auditorium, from 6 to 8 PM. Residents of the Village are encouraged to attend this meeting and let ODOT know of your concerns and objections regarding the new preferred route for the Eastern Corridor, which would go right through the South 80 Gardens and Hiking Trails Park. The main objections to this rerouting of the Eastern Corridor include:

- 1. Destabilization of the Miami Bluff hillside and further loss of the Indian serpent mound earthwork at the top of the Bluff from landslides caused by major excavation at the base of a volatile hillside
- 2. Possible loss of National Historic Landmark Designation
- 3. Destruction of Native American Archeological Site (Prehistoric village just discovered by University of Cincinnati)
- 4. Negative environmental impact on our park and nature trails
- 5. Significant reduction in Village of Mariemont parklands
- 6. Increases in the amount of air pollution in the Village
- 7. Terrible noise pollution
- 8. Water pollution to the Little Miami River, which is listed as a National Scenic River and must be protected
- 9. Loss of wildlife habitat (In what other Hamilton County community can a short walk from your home lead you to a natural wildlife area and scenic river? Do we want to lose this unique characteristic of our Village?)
- 10. Destruction of the track used by our high school Cross-Country Track team
- 11. Impact on Concourse resulting in loss of one of the most beautiful valley views in Hamilton County
- 12. Major impact on the nearby Prevey Bird Sanctuary
- 13. ODOT's flawed analysis of alternative routes

It is important that we demonstrate to ODOT that our residents are united in our objection to this new preferred route and the impact it would have on the Village as a suburban community and a National Historic Landmark. mariemont-or-its-south-80-park. The Ohio Historic Preservation Office has joined us in objecting to the new route and stated they "are very concerned about the potentially devastating impact this proposed project will have on the rich cultural history of the area". Renowned artist, Mary Louise Holt, who is a teacher at the Woman's Art Club of Cincinnati at The Barn and who has featured Native Americans in many of her works, will be providing the Village an oil painting of the Indian village recently discovered in the South 80 by Professor Ken Tankersley. She will be doing the rendering with the support of the Mariemont Civic Association. Signed and numbered prints of Ms. Holt's work will then be made available as a way to raise funds should the Village need to enlist an attorney or other experts in our efforts. We must keep pressure on ODOT to ensure this project does not include a route through Mariemont!

CHANGES FOR THE NEW YEAR

COUNCIL MEETINGS TO BEGIN AT 7 PM

At its regular meeting on December 26th, Council voted to change the starting time of Council meetings from 7:30 PM to 7:00 PM. This change will take place with the first meeting of 2013 on January 14th. Meeting days will remain the same, with regular meetings being held the second and fourth Monday of each month. However, during the summer months of June, July, and August, Council will only meet once per month. Those meetings will be held on the second Monday of each of those months.



NEW ON-STREET PARKING REGULATIONS

Another big change that will take place in 2013 concerns on-street parking on the more narrow streets in the Village. State law would allow us to prohibit *all* on-street parking on any of our roads that are less than 26 feet wide to allow for emergency vehicles to easily navigate those roads. We didn't want to do eliminate all parking on those streets however, because parking in the Village is already at a premium. Therefore,

Chairman Dennis Wolter and other members of the Safety Committee began working over a year ago with Asst. Fire Chief Tim Feichtner to create a list of streets where parking should be limited to *one side of the street only*. This would allow for emergency equipment to safely access all points in the Village while maintaining as much on-street parking as possible. It was decided these changes would be made to only five streets at a time. This would give Council the ability to notify residents of the five streets in advance of making any changes and allow residents the opportunity to make Council aware of any concerns they might have about the proposed changes. This project was a long time in coming, but necessary to improve the safety of our Village. Council approved the plan and the Safety Committee recommended that the first five streets to be effected would be Harvard Acres, Park Lane, Petoskey Avenue north and south of Wooster Pike, and Denny Place. Council passed that recommendation with a vote of 4 to 2, with Mr. Andrews and Mr. Scheeser dissenting. The next five streets slated for changes are Cachepit Way, Murray Avenue between West Street and Grove Avenue, Murray Avenue between Rowan Hill and Lytle Woods, Pocahontas (north and south of Wooster Pike, between Mount Vernon and Hiawatha), and Lytle Woods Place.

YARD WASTE COLLECTION SCHEDULE CHANGED

Beginning the first week of January, Rumpke will collect yard waste on Tuesdays ONLY through the months of January, February, and March. In April, yard waste will once again be picked up on Mondays and Tuesdays, in conjunction with your regular trash collection schedule. This change is taking place because the small amount of yard waste produced during the winter months can all be picked up on one truck, rather than the two trucks required during the rest of the year. All yard waste collected will still be taken to *Compost Cincy*, a company that processes the yard waste with composted



materials to make usable landscaping material. This agreement between the Village, Rumpke, and the composting facility is another measure we are taking to promote environmentally responsible disposal of waste. It is part of what helped us achieve such a high recycling rate, which in turn leads to the Village receiving more in Residential Recycling Incentive funds.



ECOMONIC GROWTH ON TRACK AT THEATER

Construction continues to move along to enlarge the Mariemont Theater for the addition of two new screens which should be in sometime this summer. This project is a prime example of what can be accomplished when we all work together. That is why I want to extend a special thank you to the Mariemont School Board and to Spinnenweber Builders for their willingness to partner with the theater and the Village to make this expansion a reality and to bring more business into the Village.

DUKE ENERGY OFFERS APPLIANCE RECYCLING PROGRAM

Residents often call the Village office to ask how they can dispose of an old refrigerator or freezer. All we could do was refer them to companies who were certified to remove the freon, but would charge residents for that service and for taking the old appliance away. I attended the Hamilton County Municipal League meeting this month and a representative from Duke Energy introduced a new program that allows residents to recycle their old refrigerators and freezers for FREE! They will even pick it up for FREE! On top of that, if your appliance is still working, they will send you a check for \$30 for participating in the recycling program! This program was established to encourage homeowners to get rid of secondary refrigerators and freezers, which can add up to \$150 to a home's electric bill each year. It will also encourage people to upgrade to newer, more energy-efficient appliances. SIDEWALK REPAIRS TO CONTINUE IN 2013

The program we started in 2012 to sand down sidewalk trip hazards caused by roots from Village-owned trees was very successful. We have had nothing but positive comments about the work that was done and we estimate that this method of repairing the sidewalks saved us \$10,000 over the traditional method of removing the damaged slabs and pouring new ones. We want to keep this program going, but we need your help to identify areas that need fixing. Please call the office at 271-3246 by the end of February with the address nearest to any slabs you feel should be sanded down to eliminate a trip hazard. We will add those areas to our list for review and get the work done as soon as possible.
